



ON THE ROAD AGAIN

It's fall, the Denver Gem & Mineral Show is over, and it's time to hit the road for our annual road trip to visit our daughter in southern Oregon. This year we went via Boise, Idaho to attend a USGS retirees reunion. The drive to Boise was somewhat less scenic than it should have been because of smoke and haze from wildfires in Idaho, Washington and California. We could barely see Longs Peak from I-25. Boise's a good city to visit, with lots to see and do (museums, shops, restaurants, wineries, and rafting). They've got a small mining museum located at the Territorial Prison museum (also worth touring).

While in Boise, a friend arranged for us to visit the Willow Creek jasper mine, owned and operated by Larry Ridley. This was a rare treat, because Larry doesn't often allow visitors to the mine. The mine is a small operation – usually just Larry, his wife Mary, and a couple other helpers. It's located about 15 miles northwest of Boise, and has been in operation for over 40 years. It's accessible by a 2-mile, rough 4-wheel drive road that we walked.

The jasper is found within large nodules that are surrounded by hard rhyolite. Larry has been told by visiting geologists that the nodules were probably formed deep within the earth, then brought to the near surface along volcanic vents. Mining the nodules is difficult hard rock mining. Explosives are used to loosen the nodules and once loose, a backhoe is used to free them. Sledgehammers and wedges are then used to split the nodules to expose the jasper.

Willow Creek jasper is considered to be some of the finest porcelain jasper in the world. It's known for its subtle pastel colors, streamer patterns, and egg or orb patterns. It takes an extremely high polish and is much sought after by collectors. Some examples of polished free-form cabs can be seen on Larry's web site, <a href="https://www.willowcreekjasper.com">www.willowcreekjasper.com</a>. You can also purchase

slabs ready for cabbing directly from the web site, or you can look for Larry at the Quartzite show. We were allowed to collect some pieces from an inactive area of the mine, and we came home with a few pieces that we'd like to get cut and polished.
